SCHOLARSHIP POLICY

SCHOLARSHIP POLICY

The objective of this policy is to define the eligibility criteria for awarding scholarships to students who exhibit outstanding academic performance, exceptional skills, or require financial assistance. It is designed to support students in their educational journey while fostering a diverse and inclusive learning environment.

Scope:

This policy applies to all students enrolled in undergraduate programs at the University.

Policy:

The University provides the following types of scholarships to students:

a. Merit-Based Scholarships:

Awarded to students who demonstrate outstanding academic performance, such as a high CGPA or exceptional test scores. All enrolled students at the university are eligible for these scholarships.

b. Need-Based Scholarships:

Awarded to students requiring financial assistance to continue their higher education. These scholarships are available to students from economically disadvantaged backgrounds, female students, candidates belonging to Scheduled Castes (SC) Scheduled Tribes (ST), Other Backward Classes (OBC), and differentlyabled students.

c. Community Merit Scholarships:

These scholarships support individuals from local communities, or specific regions associated with the institution, encouraging their academic growth and strengthening their ties with the university.

d. Talent-Based Scholarships:

Awarded to students with remarkable skills in sports, arts, music, or other specialized fields. These scholarships are available to all students enrolled in the university.

Eligibility Criteria:

To be eligible for a scholarship, a student must meet the following conditions:

- Be enrolled full-time in a UG, PG program at the University.
- Demonstrate financial need (for need-based scholarships)
- Demonstrate academic achievement (for merit-based scholarships)
- Demonstrate exceptional talent (for talent-based scholarships)

Scholarship Amount:

The University has fixed scholarship amounts for each type of scholarship, based on available funding and the number of qualified candidates. The award amounts may vary from year to year, based on available funding and other factors. Any student can claim only one scholarship.

Merit-Based Scholarships:

1. Scholarships through MBUCET for UG Programs in Engineering

Scholarship Percentage	Eligibility
100%	MBUCET – Rank 1 to 25 with min. 95% marks or equivalent CGPA in 10+2 Board Examinations
75%	MBUCET – Rank 26 to 50 with min. 95% marks or equivalent CGPA in 10+2 Board Examinations
50%	MBUCET – Rank 51 to 100 with min. 95% marks or equivalent CGPA in 10+2 Board Examinations
10%	MBUCET – Rank 101 to 200 with min. 95% marks or equivalent CGPA in 10+2 Board Examinations

2. Scholarships through JEE Mains for UG Programs in Engineering

Scholarship Percentage	Eligibility
100%	Above 98 Percentile
75%	95 to 97.99 Percentile

3. Scholarships through APEAPCET for UG Programs in Engineering

Scholarship Percentage	Eligibility
100%	APEAPCET Rank 1 to 500 and 95% and above in the qualifying examination and not eligible for Govt. Financial Assistance
75%	APEAPCET Rank 501-1000 and 95% and above in the qualifying examination and not eligible for Govt. Financial Assistance
25%	APEAPCET Rank 1001-3000 and 95% and above in the qualifying examination and not eligible for Govt. Financial Assistance
10%	APEAPCET Rank 3001-5000 and 95% and above in the qualifying examination and not eligible for Govt. Financial Assistance

4. Scholarships through 10+2 Board Marks (Non Engineering UG Programs for which MBUCET is not conducted)

Scholarship Percentage	Eligibility
25%	Above 95% Marks or equivalent CGPA in the qualifying Examinations
10%	91% to 95% Marks or equivalent CGPA in the qualifying Examinations

5. Scholarships for PG Programs (only for M.Sc., MBA and MCA)

Scholarship Percentage	Eligibility
75%	Above 96% Marks or equivalent CGPA in the qualifying Examinations and Rank 1- 100 in the corresponding entrance test conducted by Govt of AP
50%	Above 90% Marks or equivalent CGPA in the qualifying Examinations and Rank 1- 100 in the corresponding entrance test conducted by Govt of AP
25%	Above 90% Marks or equivalent CGPA in the qualifying Examinations and Rank 101-200 in the corresponding entrance test conducted by Govt of AP
10%	Above 90% Marks or equivalent CGPA in the qualifying Examinations and Rank 201-500 in the corresponding entrance test conducted by Govt of AP

***All merit scholarships are applicable on tuition fee only.**

Need-Based Scholarships:

1. Children of the Film Fraternity:

Children of the film fraternity who possess an industry-affiliated union card are eligible for a 10% tuition fee waiver.

2. Children of Ex-Servicemen:

Children of ex-servicemen are eligible for a 10% tuition fee waiver.

3. Single Girl Child:

To encourage girl students to pursue higher education, the University offers a 10% tuition fee waiver.

Community Merit Scholarships:

1. Scholarships for Children of Indian Armed Forces

Children of Indian Armed Forces personnel (Army, Navy, and Air Force) who are domiciled in Andhra Pradesh or Telangana are eligible for 50% tuition fee waiver.

Children of Armed Forces personnel from other states will receive 10% tuition fee waiver.

2. Children from Areas within a 50 km Radius (Rural Villages Specified in Annexure – I):

Students from rural areas within a 50 km radius of the University are eligible for a 10% tuition fee waiver subject to economic condition

3. Children Recommended by Local Panchayat Sarpanch:

Students from rural areas within a 50 km radius of the University and recommended by a local panchayat sarpanch are eligible for a 20% tuition fee waiver. A maximum of two students from each panchayat can avail this scholarship per year.

4. Children of Sree Vidyanikethan Educational Institutions and MBU Employees:

A 25% tuition fee waiver is provided for up to two children of employees of Sree Vidyanikethan Educational Institutions and MBU, subject to a minimum of two years of service by the employee at the time of admission

5. Alumni of Sree Vidyanikethan Educational Institutions:

Students who studied at any of the institutions under Sree Vidyanikethan Educational Institutions and are seeking admission to the University are eligible for a 10% tuition fee waiver.

6. Children of SVEI Alumni:

Children of alumni of Sree Vidyanikethan Educational Institutions are eligible for a 10% tuition fee waiver.

7. First Graduate Scholarship for Students of the Rayalaseema Region:

Students from the Rayalaseema Region (erstwhile districts of Anantapur, Kurnool, Kadapa, Chittoor, and Nellore) who are the first in their family to pursue higher education are eligible for a 10% tuition fee waiver, subject to securing a minimum of 95% marks in the qualifying examination.

*** All Need based and Community merit scholarships are subject to a minimum of 60% marks in the qualifying examination and the condition that they are not receiving any other scholarship / financial assistance from the government or the management.**

Talent-Based Scholarships:

To encourage Sports and Games, students who have won gold/silver medals International / National / State events are eligible for the following Scholarship:

Scholarship Percentage	Eligibility
100%	Olympics/ Commonwealth/Asian/South Asian Games
50%	National Games
25%	State Games

Scholarships for M.Tech Programs

1. A 20% fee waiver and a monthly stipend of ₹5,000 will be provided to APPGECET rankers who secure admission into M.Tech programs, subject to the condition that their APPGECET rank is between 1 and 500, and they have a minimum of 60% in the qualifying examination.

2. A 10% fee waiver and a monthly stipend of ₹5,000 will be provided to APPGECET rankers who secure admission into M.Tech programs, subject to the condition that their APPGECET rank is above 501, and they have a minimum of 60% in the qualifying examination.

3. A monthly stipend of ₹12,000 will be provided to GATE-qualified students who secure admission into M.Tech programs, subject to the condition that they have a minimum of 60% in the qualifying examination.

The available scholarships information shall be posted in Mohan Babu University website (www.mbu.asia) and shall be updated year after year.

Scholarship Renewal Guidelines:

Scholarships may be renewable for the entire duration of the course, provided the recipient maintains satisfactory academic progress and meets the eligibility criteria. Scholarships are awarded on a semesterwise basis.

To continue receiving the scholarship from the 2nd semester onwards, students must:

- Maintain a minimum CGPA of 8.5
- Achieve at least 90% attendance
- Uphold discipline, with no record of indiscipline

All fee waivers and scholarships apply only to tuition fees and are subject to the decision of the Scholarship Committee.

At the end of the first semester, there will be a call for applications. The committee will review all applications and determine the quantum of assistance for eligible candidates. The scholarship, fee concession, or waiver amount will be adjusted against subsequent fee payments.

Review and Evaluation:

The BOM & Academic Council shall review and evaluate the scholarship program annually, to ensure that it is meeting its intended goals and objectives.

Confidentiality:

All personal and financial information submitted by applicants shall be kept confidential and used only for the purpose of evaluating scholarship applications.
