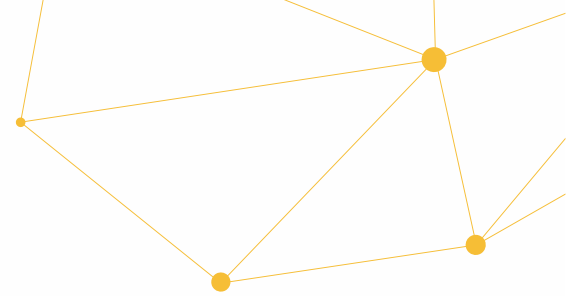
ABOUT THE CONFERENCE
